SELECTION

The selected student must meet the admission requirements of the host institution and may have to fulfill other conditions, prerequisites and documentation for the host institution. The selected student will be nominated by the home institution for admission as an exchange student of the host institution in the following academic year, to pursue the courses described in the Learning Agreement negotiated and approved by the parties involved (see Annex A).

Both institutions will select students for this exchange program on the basis of merit and other non-discriminatory eligibility criteria as listed in Annex B.

EXCHANGE TERMS AND CONDITIONS

Status of Exchange Student

- a) The student from Law School of Beijing Normal University shall normally be accepted as full-time, non-degree seeking student at undergraduate or graduate level or as student in the Center for Language Studies. He/she may request to take examination on courses at the host institution. Any other appropriate status or a semester-wise combination of these affiliations shall be considered by the host institution upon request by the student.
- b) The student from Department of Law of Roma Tre University shall normally be accepted as a non-degree-seeking exchange Bachelor or Master student.
- c) Exchange students are subject to the rules and regulations of the host institution, in addition to those of the home institution. Participation in an exchange under this agreement carries no expectations of subsequent transfer to the regular degree programs of the host Faculty.

Fees & Expenses

The exchange students shall, in principle, be exempt from admission fees and all academic tuition fees at the host institution for attendance at regular academic lectures or for language programs. Students will pay the normal tuition fees at their home institution for the period of the exchange.

The exchange students are responsible for their travel and insurance expenses and such personal expenses as accommodation expenses, telephone charges, books, and expenses during vacation periods.

The institutions will make every effort to obtain, when available, scholarships and/or other financial assistance so that the financial burden for exchange students while at the host institution will be kept to a minimum. However, there is no guarantee that such financial assistance will be available and/or provided.

Participating students of both parties shall be subject to the rules and regulations of the receiving university during the time they are enrolled.

Medical assistance as well as health and accident insurance will be dealt with in accordance to the legislations of the countries involved. Both parties commit to verify the existence of basic insurance and assistance related coverage. If medical assistance or health and accident insurance are not regulated by international agreements among the countries involved, each student participating in programs under this agreement shall be required by his or her university to purchase sufficient health and accident insurance for the duration of his or her participation.

Fees not specifically covered by this agreement, and the cost of housing and meals, shall be borne by the students themselves.

EVALUATION AND GRADING SYSTEM

Universities in Italy use a 30-point scale simply divided in two: non passing (0 to 17), and passing grades (18 to 30 cum laude).

In China, Beijing Normal University assesses student performance in a course based on a hundred-mark, five-level, or two-level system. The hundred-mark system can be converted to the five-level system as follows: A(Excellent,90-100), B(Good,80-89), C(Satisfactory,70-79), D(Qualified,60-69), F(Fail, below 60). It can also be converted to the two-level system as follows: P(Pass,60-100), F(Fail, below 60).

DURATION, TERMINATION, RENEWAL

The agreement will come into force upon signature by the authorized representatives of both universities (the date being that of the final signature) and will remain in effect in the first instance for a period of 5 years (10 semesters).

After the evaluation of the outcomes of this agreement it can be renewed for following academic years. Variations and changes can be made in writing by mutual agreement of the parties. The termination of the agreement must be communicated in written by one of the parties and shall have no effect on ongoing activities until their conclusion.

Either of the parties may terminate this protocol before the expiry date by giving written notice to the other party. The termination will not have effects on ongoing activities.

This agreement is drawn up in two copies in English, each of these texts being equally authentic. Enclosures A is an integral part of this agreement, and it will be filled in by the students who intend to participate in the exchange. Both parties will receive a copy in each language. All misinterpretations will be settled by mutual assent.

ANNEX B: SELECTION CRITERIA

The home institution must ensure that the student(s) selected for the exchange program:

- i. are registered as full-time undergraduate or graduate students of the home institution;
- ii. are students of good standing at the home institution;
- iii. propose an appropriate program of study at the host institution;
- iv. show the aptitude, motivation and maturity, to thrive in the environment at the host institution;
- v. have sufficient funds for all fees, personal and living expenses for the duration of study abroad at the host institution.
- vi. language waiver: the two Universities will not ask nominated incoming students for language certifications, given that the Partner Institution will select outgoing students with a good knowledge of English language, and given a mutual trust on selection.
