Full-time workload:

-The minimum workload allowed per semester for junior visiting program is 10 credits (usually 5 courses).

Information on courses open to exchange students:

-Exchange students may select the courses which are provided by the Law school, language proficiency may be required.

-Students holding a HSK Level 6 certificate can take Chinese-taught courses with Chinese students. This rule also applies to native Chinese speakers, who must submit a HSK Level 6 certificate as required.

-Credits for courses not provided by the International Office will not be counted toward students' academic transcripts.

-All the course selection should be done within the first week after the start of the semester.

The updated list of courses will be sent one week before each semester. Please refer to the previous course list as a reference.

Academic transcript:

-The International Students Office will issue the official transcripts within the two weeks after the start of the new semester.

-The Renmin Law School receives academic transcripts from the International Students Office, with the school issuing them to students subsequently.

Study duration: one semester or two semesters

APPLICATION PROCEDURE

Nomination deadline-partners sending nomination template form given with the nomination guide to Ms LU Na's email address (lawschool-io@ruc.edu.cn) together with Ms FANG Ruting's email address (fangruting@ruc.edu.cn)

-Spring semester: October 20

-Fall semester: April 25

Application deadline-nominated students should apply through application system within the deadline

-Spring semester: November 15

-Fall semester: May 15

-Notes: Please guide the students who decided to give up the exchange opportunities or the dispatching university office send the email on the cancellation of the exchange at least two weeks before the start of the new semester.

Students DO NOT need to pay for the application fees.

Eligibility:

-Exchange students must be nominated by the RUC's partner universities.

-Exchange students must be full-time students in the home university and have completed at least one-year of study at home university.

Application documents (all the documents will be required to be uploaded in the application system)

1. The official transcripts (English version).

-Regarding the minimum GPA requirement of 3.0/4.0: In cases where the home institution employs a grading system other than the GPA scale or maintains specific academic evaluation standards, the institution is required to provide an official explanation of its grading system along with a comprehensive assessment of the applicant's academic performance. Such documentation must be accompanied by supporting materials and will be subject to formal evaluation by the admissions committee.

2. The official certificate of enrollment (English version, to prove the nominated applicants' register information at home university).

3. One recommendation letter from the Dean or Vice Dean. Academic advisor can also issue the recommendation letter.

4. The photocopy of passport.

-The validity of the passport must be later than **July 31, 2027**.

5. The signed Guarantee Statement.

6. The official HSK certificate (new test, level 6), the English proficiency certificate (TOEFL iBT 90+ or IELTS Academic 6.0+ or CEFR B2+) or the official document on the language medium of instruction.

-If applicants choose to study other Chinese-taught majors except Chinese language, the HSK6 certificate is required.

-For applicants intending to enroll in English-taught courses, submission of an official English proficiency certificate or institutional documentation verifying English as the medium of instruction is mandatory. This requirement is waived for: a) Native English speakers; b) Applicants from accredited institutions in English-speaking countries. Normally, we have English-taught classes at Law School, Business School, School of Economics, School of International Studies, School of Journalism and Communication, School of Finance and School of Public Administration and Policy. The Law School restricts course enrollment to students with demonstrated legal education background. The Business School exclusively offers English-taught courses for exchange students. Course registration in the Business School is strictly bound by academic level: undergraduates are permitted to take undergraduate courses exclusively, and graduate students may only register for graduate courses.

-Applicants wishing to combine Chinese-taught courses with English-taught courses must have this explicitly stated in their official nomination letter from the home institution. Please note the program-specific restrictions.

7. All applicants are required to submit a digital identification photograph that meets the following technical specifications:

-File format: JPG Background: white File size: 100 to 200 kilobytes (KB) Dimensions: 307 pixels (width) × 382 pixels (height)

-The photograph must strictly adhere to these specifications to ensure proper processing of application materials.

8. Research proposals (only applicable for senior-visiting applicants).
